

# **6<sup>TH</sup> ANNUAL FLORA-BAMA FISHING RODEO**

## **TRASH CAN SLAM RULES**

1. THE FLORA-BAMA TRASH CAN SLAM CHAMPIONSHIP IS A COMPETITIVE ANGLER DIVISION OF THE FLORA-BAMA FISHING RODEO. THIS TICKET MUST BE PURCHASED IN CONJUNCTION WITH THE FBFR.
2. THE ADDITIONAL COST TO ENTER THE FBFR TRASH CAN SLAM CHAMPIONSHIP IS \$20.00 PER ADULT ANGLER (13 YEARS & OVER) AND \$10.00 PER JUNIOR ANGLER (12 & UNDER).
3. ALL ANGLERS FISHING IN THIS CHAMPIONSHIP MUST POSSESS THEIR OWN FLORA-BAMA FISHING RODEO KIDS' OR ADULTS' DIVISION TICKET. ANGLERS MUST BE REGISTERED BY 12 AM ON FRIDAY, MAY 31<sup>ST</sup>, 2019 TO COMPETE IN THE FBFR TRASH CAN SLAM CHAMPIONSHIP.
4. ALL RULES, WEIGH STATION HOURS, AND DOCK PROCEDURES OF THE FLORA-BAMA FISHING RODEO APPLY TO THE FLORA-BAMA TRASH CAN SLAM CHAMPIONSHIP.
5. THE OFFICIAL BOUNDARIES TO FISH IN THE FBFR ARE FROM THE TX/LA BORDER TO CAPE SAN BLAS, FL.
6. ANGLERS IN THIS CHAMPIONSHIP COMPETE FOR THE TOP AWARD ONLY.
7. TRASH CAN SLAM WINNERS WILL BE DETERMINED BY LARGEST AGGREGATE WEIGHT OF A PARTICIPATING ANGLER'S LARGEST GAFFTOPSAIL CATFISH, LADYFISH AND BLUEFISH CAUGHT DURING THE FBFR. AN ANGLER MAY ONLY USE ONE GAFFTOPSAIL CATFISH, ONE LADYFISH AND ONE BLUEFISH TO APPLY TO THEIR TOTAL AGGREGATE WEIGHT.
8. CHEATING WILL BE HIGHLY MONITORED AND GUARDED AGAINST.
9. ALL FISH WEIGHED IN ARE SUBJECT TO INSPECTION BY MARINE BIOLOGIST ON SITE.
10. ANGLERS MAY ONLY WEIGH IN FISH ORIGINALLY CAUGHT BETWEEN THE HOURS OF 12 AM ON MAY 31<sup>ST</sup>, 2019 TO 7 PM JUNE 1<sup>ST</sup>, 2019.
11. ANGLERS MAY NOT WEIGH IN FISH CAUGHT BY ANOTHER ANGLER.
12. ANGLERS MAY NOT WEIGH IN FISH ORIGINALLY CAUGHT PREVIOUS TO MAY 31<sup>ST</sup>, 2019.
13. ALL VESSELS MUST BE IN EYESIGHT OF THE DOCKMASTER WHEN THE WEIGH STATION CLOSES TO BE ELIGIBLE TO WEIGH A FISH AFTER THE CLOSE OF THE WEIGH STATION. AN ANGLER'S ELIGIBILITY TO WEIGH A FISH IS COMPLETELY UP TO THE DOCKMASTER ONCE THE WEIGH STATION IS CLOSED.
14. AWARDS AND CASH PRIZES WILL BE DISTRIBUTED AT THE 6<sup>TH</sup> ANNUAL AWARDS CEREMONY ON SUNDAY, JUNE 2<sup>ND</sup>, 2019 AT THE FLORA-BAMA YACHT CLUB.
15. FBFR HAS THE RIGHT TO DISQUALIFY ANY BOAT OR ANGLER AT ANY TIME. THE FBFR IS NOT RESPONSIBLE FOR ANY TYPOS OR ERRORS IN THESE RULES. THE FBFR MAY CHANGE THESE RULES AT ANY TIME.
